Dear Secretary Phillips:

Valley Energy Inc, (“Company”) submits the attached Supplement No. 10 to P.S.C. No. 1 – Gas, which postpones the effective date of tariff amendments related to changes in the Public Service Law, Section 66-p. The Department of Public Service Staff has requested that the Company file this postponement to allow sufficient time for notification of the tariff sheet changes made by the Company in the case referenced above and to make certain changes to the language in the tariff amendments.

In compliance with the Public Service Commission’s January 22, 2020 notice requiring tariff amendments pursuant to changes in the Public Service Law Section 66-p, the Company issued the following revised tariff sheets on February 21, 2020 with an effective date of July 1, 2020:

Valley Energy respectfully requests a waiver of the newspaper publication requirements of PSL § 66(12)(b) as customer rates or charges will not be affected by this filing.
