Dear Secretary Burgess:

In accordance with the New York Public Service Commission's Order Approving Modifications to Fixed Costs of Gas and Fixed Cost Credits over a Three Year Period ("Order") issued December 16, 2014 in the above-referenced case, KeySpan Gas East Corporation d/b/a National Grid ("National Grid" or "Company") hereby submits tariff leaves listed on Attachment 1, to become effective on January 1, 2015.

On May 8, 2014 the Company filed tariff revisions to align the Monthly Cost of Gas and Adjustments provisions and statements with those contained in tariff leaves filed by The Brooklyn Union Gas Company d/b/a National Grid NY in Case 13-G-0439, to become effective on September 1, 2014 ("GAC Filing"). On July 22, 2014 the Company filed further revisions to clarify the fixed costs that are allocated to ESCOs.

The Order approved the aforementioned tariff revisions to become effective January 1, 2015. Furthermore, Ordering Clause No. 4 of the Order directed the Company to file any tariff modifications including previously-approved revisions from other cases into any of the tariff amendments approved by the Order, on not less than one day's notice, to become effective on January 1, 2015.

Under a separate case (Case 14-G-0330), on July 31, 2014, the Company filed tariff leaves to modify the retail access program under Service Classification No. 8 to phase-in the implementation of new transportation services for core customers which took effect November 1, 2014 ("Retail Access Filing").

In the current filing, the Company (i) integrates the changes in the two filings that affect the same tariff leaves (See Attachment 1, Part 1 – Integrating Previously Filed Language); (ii) removes stale references to Bundled Winter Sales and Virtual Storage Service because these services were eliminated in the Retail Access Filing; and (iii) revises the leaves to have a unified effective date of January 1, 2015.

Also included in this filing are tariff leaves revised to reflect the correct effective date only (See Attachment 1, Part 2 – Correct Effective Date).

Waiver of the newspaper publication requirement under Public Service Law § 66-12 and 16 NYCRR § 720-8 is hereby requested for this filing.
