Re: Notice of Detariffing Non-Basic Retail Services and Filing of New Tariffs

Dear Secretary Burgess:

Pursuant to Public Service Law Section 92-g, Verizon New York Inc. ("Verizon") notifies the New York Public Service Commission of the detariffing of certain non-basic retail services currently included in Verizon Tariffs PSC NY Nos. 1, 2, 3, 4, 5, 6, 7 and 12. Tariffs PSC NY Nos. 4, 5, 6 and 12 are being withdrawn in their entirety, with all services formerly included in these tariffs moved to Verizon New York Inc.'s Product Guide ("Product Guide"). PSC NY No. 1 is being cancelled in its entirety, with certain services formerly included in this Tariff moved to the Product Guide, and the remainder of the Tariff reissued as P.S.C. No. 15. PSC NY No. 2 is being cancelled in its entirety, with certain services formerly included in this Tariff moved to the Product Guide, and the remainder of the Tariff reissued as P.S.C. No. 16. Attachment 1 to this letter lists the supplements and revisions to the Tariffs.

Additionally, certain changes are being made to clean up the remainder of Tariffs PSC NY Nos. 15 and 16<sup>1</sup>. The Notice Relating to Detariffing of Non-Basic Telecommunications Services is provided as Attachment 2.

These tariff changes are filed to be effective on May 1, 2014. Verizon's Product Guide will be available on that date at

Customers were notified of the detariffing of non-basic retail services in a bill message in their January or February bills. Accordingly, we respectfully request that any applicable newspaper publication requirements be waived for this filing.
