Re: Tariff Changes in Connection with Detariffing of Non-Basic Retail Services

Dear Secretary Burgess:

The enclosed tariff pages, which are listed in the Attachment to this letter, are issued by Verizon New York Inc. ("Verizon") and are transmitted for filing with the Public Service Commission, State of New York, to be effective May 1, 2014.

As authorized by the recently-enacted Public Service Law Section 92-g, Verizon is transferring certain non-basic retail services from its retail tariffs to Verizon's Product Guide. As a part of this initiative, the PSC NY No. 1 Tariff will be renumbered as the PSC No. 15, and the PSC NY No. 2 will be renumbered as the PSC No. 16.

The proposed revisions change language in Tariff PSC NY No. 9 tariff to indicate that the transfer of otherwise-eligible services to the Product Guide will not affect their eligibility for resale. The revisions to PSC No. 9 and other tariffs included in this filing also note that all references to the PSC NY No. 1 shall be deemed to refer to the corresponding section of the PSC NY 15.

An Industry Letter regarding these changes will be issued to all resellers and posted on the Verizon web site on April 1, 2014. Accordingly, we respectfully request that any applicable newspaper publication requirements be waived for this filing.
