The enclosed tariff pages, which are listed in the Attachment to this letter, are issued by Verizon New York Inc. and are transmitted for filing with the Public Service Commission, State of New York, to be effective March 30, 2014.

The proposed revisions eliminate the option of having monthly billing and call detail information provided on magnetic tape, magnetic cartridge and diskette. These media are regarded as obsolete and no longer provided by the Company. Customers continue to have the option of receiving bills and call detail information on paper or electronic media.
