In accordance with the *Order Adopting Revised Gas Supply Procedures and Requirements and Directing Tariff Filings*, issued and effective October 18, 2012 in Case 0-G-0716<sup>1</sup>, the attached statements reflect the consolidation of NYSEG's two remaining Gas Supply Areas (GSA). Consolidation combines the Gas Supply Charge (with the exception of the Annual Reconciliation rate through 12/31/2013), the Merchant Function Charge, the Transition Surcharge and the Reliability Surcharge that were previously each calculated separately for the two existing GSAs. Transportation balancing charges are being consolidated over a phase-in period commencing this month and ending on April 1, 2014.
