The purpose of this filing is of a housekeeping/conforming nature to propose minor revisions, delete expired forms, and delete language to the above leaves, specifically:

- 1) Leaf No. 3 has been revised to delete the references in the Table of Contents of expired service agreement forms. These forms were applicable to customers taking service under Service Classification 11 which was eliminated in Case No. 12-E-0201.
- 2) Leaf No. 113 has been revised to delete the reference to Service Classification No. 11 as per Item No. 1.
- 3) Leaf No. 176 has been revised to add the word “certified” to Rule 34.3.4.4. This word was erroneously eliminated with the leaf filed in Case 12-E-0201.
- 4) Leaf Nos. 263.1, 263.5, and 263.6 have been revised to delete the reference to Service Classification No. 11 as per Item 1 above.
- 5) Leaf No. 269 has been revised to add the word “Optional” and correct a spelling error.
- 6) Customer Service Agreement Form “M” on Leaf Nos. 346-348 has been eliminated because this form was only applicable to customers taking service under Service Classification No. 11 as per Item 1.

7) Leaf No. 389 has been revised to eliminate the reference to Service Classification No.11 as per Item No. 1.

8) Leaf No. 408.5 has been revised to eliminate the word “existing” from Special Provision O and delete the last part of this special provision. This leaf was originally filed in Case No. 13-E-0121 issued March 20, 2013 and this Special Provision should have been revised at that time.

Attachment 1 included with this filing contains redlined leaves to show where the changes to the above leaves have occurred.

Because of the housekeeping/clarifying nature of this filing, waiver of the statutory requirements required under the State Administrative Procedures Act is requested for these leaves to become effective on thirty days notice on September 23, 2013.

Also, because of the housekeeping nature of this filing, waiver of the newspaper publication requirements of PSL §66-12 and 16NYCRR 720.8 is requested for this filing.
