Dear Acting Secretary Cohen:

Sprint is making revisions to the Telecommunications Relay Service New York P.S.C. Tariff No. 7 to:

- Add Disaster Recovery Plan requirements for NYRS;
- Revise descriptions of 911 to reflect emerging technology;
- Revise the process for intrastate carrier of choice toll calls – now carriers will rate and bill calls at the time of the call rather than receive CDR reports after the fact;
- Move to more culturally-sensitive language overall; and
- Make minor text changes throughout.


