Tariff filings to Effectuate Amendments to Public Service Law §66-j (Remote Net Metering for Micro-Hydro Electric Generating Systems) and Conforming and Reforming Changes to Standardized Interconnection Requirements (SIR).

New York State Electric & Gas Corporation (“NYSEG”) and Rochester Gas and Electric Corporation (“RG&E”) (together the “Companies”) hereby transmit for filing the enclosed tariff leaves in compliance with the New York State Public Service Commission’s (“Commission”) Order Modifying Standardized Interconnection Requirements and Modifying and Approving Tariffs, issued and effective March 15, 2013 (“the Order”), in the above referenced proceedings. These tariff leaves are transmitted for filing in compliance as identified herein and in accordance with the requirements of Appendix 7-H (electronic tariff filing system) to the Commission’s Codes, Rules and Regulations (16 NYCRR Appendix 7-H).

SIR Addendum, Revision 11

Purpose of the Filing

The Companies are filing tariff amendments in compliance with Ordering Clause 2 of the Order to add clarifying language in regards to customer eligibility for remote net-metering.

Overview

On August 1, 2012, amendments were enacted to Public Service Law (PSL) §66-j and §66-l., related to net-metering. The above mentioned Order adopts modifications to the SIR, and directs the Companies to file minor revisions to their tariffs to address confusion regarding customer eligibility for remote net-metering.

In accordance with Ordering Clause 2 of the Order, the Companies have amended their tariff leaves to include clarifying language indicating that remote net-metering is available to residential customers who own or operate a farm operation and locate solar photovoltaic, or micro-hydroelectric generating equipment on property that they own or lease<sup>1</sup>.

The Companies are also filing SIR Addendums in compliance with Ordering Clause 4, which directs the Companies to comply with the revised requirements.

Newspaper Publication

In accordance with Ordering Clause 3 of the Order, the requirements of 66(12)(b) of the Public Service Law requiring newspaper publication has been waived.
