Reasons for Proposed Revisions

This filing is being submitted to make “housekeeping” revisions to NYSEG’s and RG&E’s tariffs.

Proposed Revisions

The Companies are proposing to make the following tariff leaf revisions:

PSC 119

Leaf Nos. 6, 7, 17, 18, 19 – NYSEG is proposing to correct a reference of Section 2.B.(8) for Visually Sensitive Resource areas to Rule 2.B.(3)(c). The Company has also made updates to support prior tariff filings to achieve more consistent language between the Companies’ (“Consistency Filings”)<sup>1</sup>. More specifically, it changed “Corporation” to “Company” since there were other changes on the tariff leaves.

Leaf No. 101 – NYSEG is proposing to incorporate a section for Consumer Policies Related to Prolonged Outages which was previously submitted and approved<sup>2</sup>, however, the effective date for it and the Consistency Filing approved under Case 13-M-0551 overlapped. The tariff revision included herein consolidates these filings to ensure that the information correctly reflects what has been approved.

PSC 120

Leaf Nos. 5, 6, 11, 13 – NYSEG is proposing to correct miscellaneous misspelled words.  
Leaf No. 117.10 – NYSEG is proposing to correct the misspelling of “customer’s”.

PSC 121

Leaf No. 4 – NYSEG is proposing to remove unused lumen ratings.  
Leaf No. 14 – Correcting “fifteen days notice” to “three days notice” to be the same filing notification requirements for all of the Companies’ tariff provisions regarding the Renewable Portfolio Standard statements.  
Leaf No. 26 – Removing a reference that is no longer needed.  
Leaf No. 27 – Removing the asterisk that tied into the reference from Leaf 26 and making updates to support Consistency Filings. More specifically, it changed “Corporation” to “Company” since there were other changes on the tariff leaves.  
Leaf No. 28 – Adding a reference to provide clarification to the table.  
Leaf No. 34.3, 43, 56 – NYSEG inadvertently did not change the notation to a (+) and the proposed changes herein will provide the customer with the correct reference, and providing better formatting of table.  
Leaf No. 35 – Correcting the description for the lumen rating within the table and making updates to support the Consistency Filings. More specifically, it changed “Corporation” to “Company” since there were other changes on the tariff leaves.  
Leaf No. 36 – Providing clarification on table that the cost is per trench foot and making updates to support Consistency Filings. More specifically, it changed “Corporation” to “Company” since there were other changes on the tariff leaves.  
Leaf No. 41 & 42 - Correcting information on table.  
Leaf No. 55, 57 – Providing better formatting of table and making updates to support Consistency Filings. More specifically, it changed “Corporation” to “Company” since there were other changes on the tariff leaves.  
Leaf No. 64 – NYSEG is proposing to add the System Benefits Charge and Renewable Portfolio Standard Charge provisions to the general terms of the service class. This information was inadvertently excluded when the service classification was created and these customers are subject to these surcharges.

PSC 88

Leaf No. 12 – Correcting upper case, Index Price, to lower case, index price and making updates to support Consistency Filings.

Leaf No. 250 – Correcting reference of NYSEG to RG&E and making updates to support the Consistency Filings. More specifically, it changed “Corporation” to “Company” since there were other changes on the tariff leafs.
