Dear Secretary Burgess:

In accordance with Section 720-2 *et al.* of the Commission's Regulations, 16 NYCRR § 720-2 *et al.*, KeySpan Gas East Corporation d/b/a National Grid ("National Grid" or "Company") hereby submits the tariff leaves listed on Attachment 1 to become effective November 1, 2014.

The purpose of this filing is to amend the Company's tariff to adopt changes to the Company's retail access program under Service Classification No. 8 – Seller Service ("SC 8") to phase-in the implementation of new transportation services for core customers proposed in a collaborative among the Company, Department of Public Service Staff and ESCOs. Specifically, the Company is proposing to change the balancing provisions of its retail access program to allow the ESCOs that serve core customers to vary the amount of supply they deliver each day to match their customers' forecasted daily consumption. In turn, the Company is proposing to eliminate the swing service and associated monthly demand charges for ESCOs that serve core customers. In addition, the Company is proposing to eliminate its bundled winter supply service, to increase the amount of pipeline transportation capacity released to the ESCOs, restructure its retail access storage service and to offer ESCOs a peaking service.

In accordance with Section 720-2.3 of the Commission's Regulations, a proposed notice of this filing suitable for use under the State Administrative Procedure Act is also enclosed.
