Re: Cases 13-G-0031 and 13-G-0186, Temperature Control Amended Filing

Dear Secretary Burgess:

By the letter dated April 25, 2013, Consolidated Edison Company of New York, Inc. ("the Company") filed with the Public Service Commission ("Commission") tariff amendments to its Schedule for Gas Service, P.S.C. No. 9 – Gas ("the Tariff"), to become effective August 1, 2013. The amendments to the Gas Tariff included elimination of the Temperature Control ("TC") Option as a means of interruptions for SC 9 transportation and SC 12 sales interruptible gas service.

The effective date of the leaves was postponed to October 1, 2013, at the request of Department of Public Service Staff, to allow time for further review of the proposed changes. The effective date was further postponed to April 1, 2014, to allow the Company sufficient time to conduct outreach and education to those customers who would be affected by the changes.

On February 18, 2014, the Company requested a further postponement of the effective date to June 1, 2014, pending the Commission's decision regarding the Joint Proposal ("JP") in Cases 13-E-0030 et al. The JP proposed that the Company amend the April 25, 2013 tariff filing to allow existing temperature control customers to continue to utilize the temperature control option. In accordance with the Commission's Order Approving Electric, Gas and Steam Rate Plans in Accord With Joint Proposal, issued and effective February 21, 2014, in Cases 13-E-0030 et al., which adopted the JP with certain modifications, the Company filed tariff amendments on April 8, 2014. The City of New York was the only party that provided comments and requested one modification. Since the Company agreed with the requested modification, the Company filed amended leaves on April 15, 2014 ("April 15, 2014 Filing") to clarify that while the Company has the right to use notification as a means to interrupt TC customers in situations where the integrity of the Company's distribution system or its ability to serve the requirements of firm service customers is threatened, the exercise of this right by the Company will not result in TC customers being switched to Notification customer status.

The Company is now requesting a further postponement of the effective date to July 1, 2014, in order to allow the City of New York sufficient time to review the April 15, 2014 Filing.

The Company accordingly files Supplement No. 59 to postpone the effective date of the above-referenced tariff amendments to July 1, 2014. Supplement No. 59 is issued April 28, 2014, with an effective date of May 28, 2014. The Company also respectfully requests waiver of notice requirements of the proposed change in the effective date since it does not affect the content of the April 15, 2014 filing.
