Effective: January 1, 2017

In compliance with the REV Track Two Order issued on May 19, 2016 in Case 14-M-0101, the Company was directed to file revisions to the Company’s standby service rates to implement an offset tariff and reliability credit provision as described in the body of this letter. On August 1, 2016, the Company filed tariff revisions with an effective date of December 1, 2016 complying with this directive. This effective date of these revisions was subsequently postponed to January 1, 2017.

Ordering Clause 1 of the above Order, issued December 19, 2016, directed the utilities to make further revisions as discussed in the body of this Order. Specifically, the Company was directed to make the following revisions:

- 1) Effectuating the Multi-Party offset provision for SC 7 customers
- 2) Modifying the tariff for multi-party offset reliability credit calculation to take into account all means of demand reduction, regardless of cause, from customers that partake in a multi-party offset.
- 3) Revising the definition of summer period to June 1 through September 30
- 4) Leaf 440 has been revised to replace the phrase “output meter” with “interval meter”
- 5) Revising the tariff to indicate that the customer must request the Standby Reliability Credit, in writing, by October 14 of each year
- 6) Minor housekeeping/conforming revisions
