## Dear Secretary Burgess:

By letter dated April 18, 2016, Orange and Rockland Utilities, Inc. (the "Company") filed with the Public Service Commission (the "Commission") amendments to its Schedule for Electric Service, PSC No. 3 – Electricity to become effective August 1, 2016. This filing was made in compliance with the Commission's Order Adopting Terms of Joint Proposal and Establishing Electric and Gas Rate Plans, issued October 16, 2015, in Case No. 14-E-0493 ("Rate Order"). In the Rate Order, the Company was required to make a filing that offered additional LED street lighting options and examined the prices of its existing LED street lighting options.

On June 16, 2016, at the request of Commission Staff, the Company requested a postponement of the effective date of the proposed tariff amendments and statement to November 1, 2016, to allow time for further review of the proposed changes. The Company filed Supplement No. 16 to postpone the effective date of the tariff amendments and statement included in its April 18, 2016 filing. Supplement No. 16 was issued June 16, 2016 with an effective date of July 16, 2016. On September 13, 2016, at the request of Commission Staff, the Company requested an additional postponement of the effective date of the proposed tariff amendments and statement to February 1, 2017, to allow time for further review of the proposed changes. The Company filed Supplement No. 18 to postpone the effective date of the tariff amendments and statement included in its April 18, 2016 filing. Supplement No. 18 was issued September 23, 2016 with an effective date of October 23, 2016. Commission Staff has requested a further postponement of the proposed tariff amendments and statement. The Company accordingly files Supplement No. 21 to postpone the effective date of the tariff amendments and statement included in its April 18, 2016 filing to April 1, 2017. Supplement No. 21 is issued December 19, 2016 with an effective date of January 19, 2017.
