The enclosed tariff pages, which are listed in the Attachment to this letter, are issued by Verizon New York Inc. ("Verizon") and are transmitted for filing with the Public Service Commission, State of New York, to be effective December 8, 2016.

The proposed revisions provide for grandfathering of DS0 Special Access and IntraLATA DS0 Private Line Services in select wire centers where the Verizon network is being upgraded to all-fiber facilities.

Customers who currently have these services were notified of the grandfathering by letter in August 2016. Verizon respectfully requests that the requirements of newspaper publication be waived.
