Re: Case 15-E-0557 - In the Matter of Proposed Amendments to the New York State Standardized Interconnection Requirements (SIR) for Distributed Generators 2 MW or Less

Dear Secretary Burgess:

The enclosed tariff leaves and Standardized Interconnection Requirements Addenda, issued by New York State Electric & Gas Corporation and Rochester Gas and Electric Corporation (together the "Companies") are transmitted for filing in compliance with the requirements of the New York Public Service Commission's (the "Commission") Order Modifying Standardized Interconnection Requirements, issued and effective on March 18, 2016 (the "Order"), in the above referenced proceeding.

A list of the revised tariff leaves and Addenda to become effective April 29, 2016 are provided as Appendix A.

**Purpose and Overview of Filing**

In compliance with the Order, the Companies are filing amendments for the SIR Addenda and tariffs in compliance with Ordering Clause No. 1 of the Order.

The SIR Addenda were revised to increase the threshold for projects eligible pursuant to the Standardized Interconnection Requirements (SIR) from 2 MW to 5MW, the application process, and various technical revisions and enhancements. The Companies updated references within its tariff to the SIR Addendum to reflect the proper citation of the SIR Addendum<sup>1</sup>.
