Re: Postponement Supplement for Tariff Leaves in Case No. 15-E-0753, *Tariff Filing by Salamanca Board of Public Utilities to Establish Net Metering Services for Solar and Wind Generation for Its Residential and Non-residential Customers Under Service Classifications Nos. 1 and 2.*

Dear Secretary Burgess:

On December 23, 2015, the Salamanca Board of Public Utilities ("BPU") filed with the Commission draft new tariff leaves for PSC No. 1, Electricity containing the provisions for the purchase of electricity from new, renewable distributed generation as contained in the following:

Leaf No. 15, Revision 0

Leaf No. 16, Revision 0

These leaves were issued on December 23, 2015 and were proposed to become effective April 1, 2016. Newspaper publication regarding this filing was made in accordance with the Commission's regulations in the local newspaper on February 4, 11, 18 and 25, 2016.

The BPU consulted with Department of Public Service Staff, and Staff recommended certain revisions to the tariff along with a revised effective date. Pursuant to Staff's recommendation, attached for filing with the Commission is postponement Supplement No. 2 to P.S.C. No. 1 – Electricity issued by the Salamanca Board of Public Utilities effective April 10, 2016. The BPU requests that Supplement No. 2 be allowed to go into effect on less than 30 days' notice. The BPU also requests a waiver of newspaper publication of this Supplement and the change proposed.
