The attached statement is being issued by Niagara Mohawk Power Corporation d/b/a/National Grid (the "Company"), in compliance with the Commission's "Order Adopting Dynamic Load Management Filing with Modifications" (the "Order") in Case 15-E-0189 issued June 18, 2015.

Effective: June 1, 2016

## Reason for Filing

In conformance with the above order, performance payments are those payments made to customers during called demand response events. Performance payments compensate distribution level customers for actually reducing load on the utility's system during the called event or test hours, and can also be used to induce participants to voluntarily continue to reduce load during called hours after the mandatory load reduction obligations have expired. Sign-up or participation payments are those payments made upon enrolling in a DLM program and installing any necessary equipment (in the case of sign-up payments), or to induce customers to participate in called demand response events.

The above statement sets forth the performance payments for the summer performance period of 2016 and are applicable to Rule No. 61-Distribution Load Relief Program, Rule No. 62-Commercial System Relief Program, and Rule No. 63-Direct Load Control Program. Also in accordance with these rules, the rates shall be on statements filed with the Public Service Commission not less than 60 days before their effective date.
