Effective: June 1, 2016

On June 18, 2015, the Commission issued its Order approving the draft tariffs issued by
the utilities which proposed dynamic load management programs as directed by the Order.
Each utility was directed to submit final tariff leaves as a compliance filing on one day's notice
with an effective date of July 1, 2015. The Order also directed that commencing with the

summer 2016 capability period the utilities were to expand their dynamic load management programs and to make any other changes as deemed appropriate as directed in the Order.

On December 31, 2015, the Secretary of the Commission issued a Notice Extending Deadline to File in Case 15-E-0191 to all parties to extend the date of filing of these revisions for the 2016 capability period to February 16, 2016

In accordance with this Order, the Company is filing revisions to its' Dynamic Load Programs, Rule 61-Distribution Load Relief Program, Rule 62 – Commercial System Relief Program, and Rule 63 – Direct Load Control Program, and Rule 64 - Dynamic Load Management (DLM) Surcharge.

The proposed revisions are highlighted on Attachment 1 included with this filing.

In accordance with Ordering Clause No. 7 of the Order, the requirements of Public Service Law §66(12)(b) as to newspaper publication for the tariff amendments directed in Ordering Clause No. 3 of this Order is waived.
