Purpose of the Filing

The Companies are filing revised addenda in compliance with Ordering Clause No. 5 of the Order. Changes proposed to the Uniform Business Practices (UBP) are adopted in accordance with the discussion in the body of the Order.

Overview of Filing

The Commission has directed changes to restructure the retail market that affects provisions in the UBP. More specifically, the Commission is requiring ESCOs to provide guaranteed savings to customers or offer contracts that will further clean energy goals. Additionally, the Commission has directed changes to the UBPs to strengthen the consequences applicable to ESCOs should an ESCO fail to comply with the UBP.

Publication

In accordance with Ordering Clause No. 6, requirements for newspaper publication pursuant to Section 66(12)(b) of the Public Service Law for the tariff revisions is waived.
