Recovery of Certain NYISO Tariff Charges

Dear Secretary Burgess:

Orange and Rockland Utilities, Inc. ("O&R" or the "Company") hereby submits for electronic filing with the Public Service Commission (the "Commission") the following tariff leaves reflecting revisions to its Schedule for Electric Service, P.S.C. No. 3 – Electricity (the "Electric Tariff").

These leaves, which make changes to General Information Section No. 15 – Market Supply Charge ("MSC"), are issued December 23, 2015, to become effective January 26, 2016.

Reason for Filing

On September 10, 2015, the Company made a tariff filing in Case 15-E-0519 to provide for recovery through the MSC of charges recovered under the New York Independent System Operator ("NYISO") tariff for the following: NY Transco Charges; projects approved by the Commission in Case 12-E-0503; and projects approved by the Commission in Case 13-E-0488. The effective date of that filing is currently postponed to January 26, 2016.

In response to a request from Department of Public Service Staff, the Company is submitting a revision to the MSC cost recovery provisions filed on September 10, 2015, to better accommodate the review and approval process for transmission projects by the Federal Energy Regulatory Commission (the "FERC"), the NYISO and/or the Commission.

Tariff Changes

The revised tariff leaves provide for the Company to recover, through the MSC, NYISO charges allocated to the Company resulting from transmission projects approved through the

FERC, NYISO and/or Commission processes ("NYISO Transmission Charges"). NYISO Transmission Charges include, for example, FERC-approved New York Transco, LLC charges, FERC-approved charges resulting from projects approved by the Commission in Case 12-E-0503, and FERC-approved charges resulting from projects approved by the Commission in Case 13-E-0488, et al. NYISO Transmission Charges will be billed in the same manner as Ancillary Services Charges and the NYPA Transmission Adjustment Charge (*i.e.*, on a per-kWh basis) and will be added to these charges and shown as one line on the Statement of Market Supply Charge.

Conclusion and Notice

This filing is issued with an effective date of January 26, 2016, the same as the current effective date of the filing made on September 10, 2015. The Company requests waiver of newspaper publication, because publication was made on September 17 and 24 and October 1 and 8, 2015, of the changes filed on September 10, 2015.
