> **RE:** Case 15-E-0229, Implementation of Projects and Programs That Support Reforming the Energy Vision

Dear Secretary Burgess:

Consolidated Edison Company of New York, Inc. ("Con Edison" or the "Company") is filing with the Public Service Commission (the "Commission") an amendment to its Schedule for Electricity Service, P.S.C. No. 10 – Electricity (the "Electric Tariff"), applicable to its customers in the City of New York and the County of Westchester. The Company is also filing an amendment to its Schedule for New York Power Authority ("NYPA" or "PASNY") Delivery Service, P.S.C. No. 12 - Electricity (the "PASNY Tariff), applicable to delivery by the Company of power and associated energy to Authority Public Customers under the PASNY Tariff.

The revised tariff leaves identified below have an effective date of January 15, 2016:

Reason for Filing

Pursuant to Ordering Clause 3 of the Commission's <u>Order Implementing With Modification the Targeted Demand Management Program, Cost Recovery, and Incentives</u>, (the "Order"), issued and effective December 17, 2015, in Case 15-E-0229,

the Company is filing amendments to its Electric and PASNY Tariffs for recovery of costs associated with the Targeted Demand Management ("TDM") program and Reforming the Energy Vision Demonstration Projects. These costs will be collected from electric customers through the Monthly Adjustment Clause ("MAC") of the Electric Tariff and from NYPA through a surcharge under the PASNY Tariff unless recovered in base rates. Costs will be collected under each Tariff on a pro-rata basis based on the ratio of forecasted rate year delivery revenues under that Tariff to the total combined forecasted delivery revenues under the Electric and PASNY Tariffs.

Tariff Changes

To implement the changes described above, the Company has added a new component to General Rule 26.1 – MAC. It has also added a new component, "Charges Associated with the Targeted Demand Management Program and Demonstration Projects," to Section (H) – Other Charges and Adjustments of the "Additional Delivery Charges and Adjustments" section of the PASNY Tariff.

Conclusion and Notice

As directed by Ordering Clause 3 of the Order, this filing is being made within thirty days of issuance of the Order, to become effective on not less than one day's notice on January 15, 2016. Pursuant to Ordering Clause 11 of the Order, the requirement for newspaper publication was waived.
