The Companies are filing tariff amendments in compliance with Ordering Clause No. 1 of the Order for utilities to continue accepting applications for net metering and process interconnections notwithstanding the level of ceilings on net metered capacity. The temporary removal of the ceiling caps is applicable to all technologies eligible for net metering. The ceiling caps will be re-established upon resolution of a process to evaluate the value of distribution (commonly referred to as the “value of D”) to be concluded in 2016.

Requirements of Public Service Law Section 66 (12) (b) as to newspaper publication of the tariff revisions are waived pursuant to the Ordering Clause No.2.
