RE: CASE 14-G-0315 – Tariff filing by KeySpan Gas East Corporation d/b/a National Grid to modify P.S.C. No. 1 – Gas by amending and clarifying provisions related to electric generators that take transportation service.

## Dear Secretary Burgess:

In accordance with the New York Public Service Commission's ("Commission") Order Approving the Tariff Amendments with Modifications ("Order") issued July 17, 2015 in the above-referenced case, KeySpan Gas East Corporation d/b/a National Grid ("National Grid" or "Company") hereby submits the following tariff leaves and supplement to become effective on August 1, 2015:

Thirteenth Revised Leaf No. 14 Eighth Revised Leaf No. 156 Twelfth Revised Leaf No. 157 Fourth Revised Leaf No. 157.1 Third Revised Leaf No. 212 Tenth Revised Leaf No. 216 To Schedule for Gas Service, PSC No. 1-GAS

In accordance with Ordering Clause No. 1 of the Order, the Company is filing further modifications on not less than one day's notice to become effective on August 1, 2015 to revise the locational language for cogeneration and distributed generation customers to accurately reflect Public Service Law. Specifically, the Company is modifying the language in the Special Provisions Section of Service Classification Nos. 15 – High Load Factor Service and 17 – Baseload Distributed Generation Service to clarify that the electricity generated by the customer may also be used to supply other customers within a defined geographical location "which shall include customers that are eligible to be served by a cogeneration facility, as defined in Section 2 of the New York Public Service Law that is less than 50 Megawatts."

Ordering Clause No. 4 of the Order directs the Company to file, on not less than one day's notice to become effective on August 1, 2015, any tariff revisions incorporating previously Honorable Secretary Burgess Page 2 of 2

approved provisions by the Commission since the tariff amendments were filed pursuant to the above-referenced case. Accordingly, the Company is hereby integrating the changes approved in the Order with the currently effective tariff leaves.

In accordance with Ordering Clause No. 5 of the Order, the newspaper publication requirement under Public Service Law § 66(12) (b) and 16 NYCRR § 720-8.1 is waived for this filing.
