Dear Secretary Burgess:

The enclosed tariff pages, which are listed in the Attachment to this letter, are issued by Verizon New York Inc. and are transmitted for filing with the Public Service Commission, State of New York, to be effective October 15, 2016.

The proposed revisions provide for administrative updates to the tariff to remove references to Corrections Collect Calls and Inmate Service. Verizon has not provided Inmate Service or Corrections Collect Calls in New York for many years. In addition, a correction to a reference on Page 7 of PSC No. 15, Section 11 is being made.
