The 2010 Rate Order had approved RDM targets where Rate Year 3 targets continued to repeat annually until changed by the Commission¹. The Companies are filing revised service classification or sub-classification specific RDM surcharge/credit rates to reconcile the actual collections to the targets set forth in the 2010 Rate Order for the period September 1, 2015 through April 30, 2016. The 2016 Rate Order establishes new targets beginning May 1, 2016.

In accordance with the Companies' filed tariffs, the Companies are providing the revised RDM surcharge/credit rates on not less than 30 days' notice, to become effective on August 1st.
