Dear Secretary Burgess:

Pursuant to Public Service Commission Orders, issued and effective June 17, 2015 and February 26, 2016, in the above captioned proceeding, Central Hudson Gas & Electric Corporation ("Central Hudson" or "the Company") hereby files the following further amended tariff leaves to its Schedule for Electric Service, PSC No. 15 – Electricity:

PSC No. 15 – ELECTRICITY

11<sup>th</sup> Revised Leaf No. 107

On November 18, 2015 in Case 14-E-0318, the Company filed a petition to waive its monthly billing requirement for the subset of customers categorized as net-metered customers. As part of that petition, the Company also requested approval to prorate the Energy Cost Adjustment Mechanism ("ECAM") using billing days for all electric customers similar to the way the Gas Supply Charge (GSC) is prorated based on the number of days each GSC is in effect during the gas customer's billing period. Pursuant to Ordering paragraph two in the February 26, 2016 Order, on June 1, 2016 the Company filed tariff amendments to effectuate pro-ration of the ECAM to be simultaneous with the Rate Year 2 Compliance monthly billing implementation.

The proration language filed on June 1, 2016 inadvertently failed to reference an exception to a particular class of customers due to a programming limitation. ECAM factors for Service Classification No. 5 Area Lights will continue to use the ECAM factors in effect the night the bill is issued. Area lights are billed in advance through the end of the month when the billing occurs, resulting in an inability to prorate factors billed to these customers.

Further, as directed by Ordering paragraph 3 of the February 26, 2016 Order, the requirements of Public Service Law §6(112)(b) and 16 NYCRR §720-8.1 as to newspaper publication of the revisions are waived.
