RE: Cases14-E-0423 and 15-E-0191, Order Adopting Dynamic Load Management Program Changes with Modifications

Dear Secretary Burgess:

Orange and Rockland Utilities, Inc. (the "Company") hereby submits for electronic filing with the Public Service Commission (the "Commission") 2nd Revised Leaf No. 156.3 and 2nd Revised Leaf No. 157.3 to its Schedule for Electric Service, P.S.C. No. 3 – Electricity (the "Tariff").

These revised Tariff leaves make changes to General Information Section 13 – Service Classification Riders. These Tariff leaves are issued May 26, 2016, with an effective date of June 1, 2016.

Reason for Filing

This filing is being made in compliance with the Commission's <u>Order Adopting Dynamic Load Management Program Changes with Modifications</u> issued and effective May 23, 2016 in Case Nos. 14-E-0423 and 15-E-0191 (the "May Order"). The May Order approved the Company's proposed program changes to its three distribution-level demand response programs: the Direct Load Control Program ("DLCP"), the Commercial System Relief Program ("CSRP"), and the Distribution Load Relief Program ("DLRP"), with one minor change related to the sign-up date for the CSRP and DLRP. Such change was to be filed on not less than one day's notice effective June 1, 2016.

Tariff Changes

To comply with the May Order, the Company has made the following change to the Application and Terms of Service section under both the CSRP (Rider E) and DLRP (Rider F):

 The Company added language that only applies to the Summer of 2016 capability period. For Summer 2016 only, customers seeking to sign up for either the CSRP or DLRP may submit completed applications by May 25 for a June 1 commencement date provided that the customer has already installed interval metering and associated communications at the time of application. Also for the Summer of 2016 only, customers may submit completed applications by June 15 for a July 1 commencement Received: 05/26/2016

date provided that the customer has interval metering installed by June 15 and has meter communications service in place by June 30.

Conclusion and Notice

As directed by the May Order, the Company is filing these tariff amendments no later than May 31, 2016, to become effective June 1, 2016. Pursuant to Ordering Clause 5 of the May Order, the requirement for newspaper publication is waived.
