**RE: Case 19-E-0079 – In the Matter of the Continuation of Standby Rate Exemptions**

Dear Secretary Phillips:

The following tariff amendments, issued by Niagara Mohawk Power Corporation d/b/a National Grid (the “Company”) are being transmitted for filing in compliance with the *Order Continuing and Modifying Standby Rate Exemptions* (the “Order”) issued by the New York Public Service Commission on May 18, 2023 in the above referenced proceeding.

In compliance with Ordering Clauses 1, 2, 3, 4, and 5 of the Order, the Company’s tariff revisions continue the exemptions from standby rates for residential and small commercial customers, energy storage systems, and certain designated technologies that qualify as renewable energy systems under the Climate Leadership and Community Protection Act (“CLCPA”) and those used for administering the Clean Energy Standard. In further compliance with the Order, the Company revised its tariff to eliminate standby rate exemptions for certain previously eligible technologies that do not qualify as renewable energy systems.

In compliance with Ordering Clause 1 of the Order, the Company is filing on not less than one day’s notice to be effective on a temporary basis on June 1, 2023. A revised redline version of the tariff is also provided as Attachment 1.

In accordance with Ordering Clause 6 of the Order, the requirements of PSL §66 (12) (b) and 16 NYCRR §720-8.1 concerning newspaper publication of the proposed tariff amendments have been waived.
