Purpose of Filing

The Companies are filing amendments to their respective tariffs in compliance with Ordering Clause No. 7 of the Order to incorporate the Phase 2 Arrears Reduction Program provisions into the existing Arrears Relief Program tariff. The tariff amendments include adding the Phase 2 Arrears Reduction Program to the tariff as well as specifying the cost recovery periods. The Companies shall file updated Arrears Relief Program Statements (ARP) one month after the first application of the arrears relief credits to customer accounts in accordance with the Phase 2 Arrears Report filed in the above referenced proceedings, dated December 23, 2022.

Newspaper Publication

In accordance with Ordering Clause No. 8 of the Order, the requirements of Public Service Law §66(12)(b) and 16 NYCRR §720-8.1 that require newspaper publication of the tariff amendments be made prior to the effective date of the tariff amendments are waived. Proof of newspaper publication will be filed not later than six weeks following the effective date of the tariff amendments.
