RE: Cancellation of Village of Sherburne Tariff – P.S.C. No. 1 - Electricity

Dear Secretary Phillips:


The Village of Sherburne (“Sherburne”), a municipal electric utility owned and operated by the Village of Sherburne, New York, has decided to pursue power service from the New York Power Authority (“NYPA”) as a full requirements customer. Sherburne currently serves its customers under its tariff filed with the Public Service Commission (“Commission”), P.S.C. No. 1 – Electricity. Sherburne commenced receiving power service as a full requirements customer of NYPA on January 1, 2023. Since Sherburne has begun receiving all of its power from NYPA for distribution and sale to Sherburne customers, the Public Service Law, and thereby Commission and Department of Public Service regulation, does not apply to Sherburne as of January 1, 2023.

Sherburne’s tariff under NYPA remains identical to the current tariff on file at the Commission. Sherburne does not anticipate a change to its tariff and associated service schedules until a future rate redesign may be initiated with NYPA.

Pursuant to Staff’s recommendation, attached is Sherburne’s Supplement No. 4 to P.S.C. No. 1- Electricity, which cancels Sherburne’s tariff in its entirety with an effective date of March 23, 2023.

Newspaper publication of the tariff cancellation at the Commission will be made in accordance with the Commission's regulations in the local newspaper for four consecutive weeks, on February 23, March 2, 9 and 16, 2023, and will file proof of publication with the Secretary to the Commission.
