Dear Secretary Phillips:

The attached Revenue Decoupling Mechanism ("RDM") Statement, issued by Niagara Mohawk Power Corporation, d/b/a National Grid (the "Company"), is being transmitted for filing in accordance with the requirements of the State of New York Public Service Commission.

Revenue Decoupling Mechanism Statement No. 43

To P.S.C. No. 220 Electricity

Effective: April 1, 2023

In compliance with the above Order and the "Order Approving Limited Waiver of Tariff Provisions" issued on March 17, 2023 in Case No. 20-E-0380, the Commission approved the limited waiver of Rules 57.1.3 and 57.1.3.3 of the Company's electric tariff schedule, PSC No. 220 – Electricity ("Electric Tariff"). This limited waiver allows the Company to recover Electric Energy Transmission Efficiency Transition Implementation Plan (ETIP) credits that were inadvertently excluded from billed delivery service revenues for certain customer groups in the RDM calculation from April 2018 through March 2021.

The limited waiver approves the following amounts to be recovered with RDM rates for the SC2D, SC3, and SC3A Classes:

- 1. Service Classification No. 2D:** Due to the relatively small dollar amount for the SC-2D Reconciliation Group, the Company will include the under recovery of \$22,923 in the Company's next annual RDM reconciliation filing in June 2023.
- 2. Service Classification No. 3:** Beginning with this statement filing, the Company will recover the SC-3 under-recovery of \$2,147,615 over a 15-month period, beginning in April 2023. This will result in an incremental increase in the SC-3 RDM rate of \$0.11 per kW per month.
- 3. Service Classification No. 3A:** Beginning with this statement filing, the Company will recover the SC-3A under-recovery of \$16,240,636 over a 60-month period, beginning in April 2023. This will result in an incremental increase to the SC-3A RDM rate of \$0.29 per kW per month.

Attachment 1 included with this filing displays a monthly summary of the ETIP costs that were not recovered from April 2018 through March 2021. Attachment 2 included with this filing displays the derivation of these rates.

The RDM Statement is effective April 3, 2023 through June 28, 2023 for batch billed customers and April 1, 2023 through June 30, 2023 for calendar month billed customers.
