Dear Secretary Phillips:

In accordance with the *Order Authorizing Alternative Recovery Mechanism for Unbilled Fees* (issued and effective June 17, 2022) in Cases 17-E-0238, 17-G-0239, 19-G-0309, 19-G-0310, 20-E-0380, and 20-G-0381 (the "Order"), The Brooklyn Union Gas Company d/b/a National Grid NY (the "Company") submits for filing the gas tariff leaves and statements as listed on Attachment A. Specifically, this Order directed the Company to file, on not less than three days' notice, tariff amendments necessary to effectuate Late Payment Charges and Other Fees ("LPCO"), to take effect on July 1, 2022. In addition, the Company is filing the unit rate calculation for the Statement of Late Payment Charges and Other Fees ("LPCO"), to take effect as of July 1, 2022. Attachment B of this filing displays the derivation of these charges. Since the LPCO rate is one of the components included in the Statement of Delivery Rate Adjustment ("DRA"), the DRA has been updated accordingly, also to take effect as of July 1, 2022.

Ordering Clause No. 10 of the Order waives Public Service Law §66 (12) (b) and 16 NYCRR §720-8.1 regarding the requirement of newspaper publication for these revisions. The Company will provide notice to the public of the tariff changes once a week for four consecutive weeks in general circulation newspapers in the areas affected by the changes and file with Commission proof of the notices.
