Dear Secretary Phillips:

Consolidated Edison Company of New York, Inc. (the "Company") is filing with the Public Service Commission (the "Commission") amendments to its Schedule for PASNY Delivery Service, P.S.C. No. 12 – Electricity (the "PASNY Tariff"), <sup>1</sup> applicable to delivery by the Company of power and associated energy to New York Public Authority ("NYPA") Customers under the PASNY Tariff.

The revised Tariff Leaves, which are identified in Appendix A, and Supplement are filed to become effective on May 17, 2022.

## Reason for Filing

Ordering Clause No. 1 of the Commission's <u>Order Approving Tariff Amendments</u>, issued and effective May 13, 2022, in Case 15-E-0751 (the "Order"), directed the Company to file a supplement cancelling the tariff amendments that were filed on January 10, 2022 in the above-referenced proceeding. The Company made the January 10, 2022 filing to allow certain customers of NYPA who are served under the PASNY Tariff to be eligible for Phase One Net Energy Metering compensation.

Ordering Clause No. 2 of the Commission's Order directed the Company to refile, on not less than one day's notice, further tariff revisions with an effective date of May 17, 2022.

(the "Company"), dated March 10, 1989, for the Delivery by the Company of Power and Associated Energy to Authority Public Customers."

Accordingly, the Company is filing Supplement No. 33 to P.S.C. No. 12 – Electricity. This supplement cancels the PASNY Tariff leaves filed in Case 15-E-0751 on January 10, 2022, as directed by Ordering Clause No. 1 of the Order. Also included in this filing are the PASNY Tariff revisions, which update the effective date from June 1, 2022 to May 17, 2022 as directed by Ordering Clause 2 of the Order. The revised tariff leaves are identified in Appendix A.

## **Conclusion and Notice**

These tariff revisions are being filed on not less than one day's notice to become effective on May 17, 2022. As specified in Ordering Clause No. 3 of the Order, the Commission waived the requirement for newspaper publication.
