## RE: Case 15-E-0751, In the Matter of the Value of Distributed Energy Resources

Dear Secretary Phillips:

Consolidated Edison Company of New York, Inc. (the "Company") is filing the Statement of Customer Benefit Contribution ("CBC Statement") to the Schedule for Electricity Service, P.S.C. No. 10 – Electricity (the "Electric Tariff").

CBC – Statement No. 3 to P.S.C. No. 10 – Electricity

The CBC Statement is being issued on May 17, 2022 to become effective on June 1, 2022.

## **Reason for Filing**

This filing is made pursuant to the Net Metering and Value Stack Tariff for PASNY Customer-Generators in the General Provisions of the Schedule for PASNY Delivery Service for Consolidated Edison Company of New York, Inc. ("PASNY Tariff"), which requires the first statement to Customer Benefit Contribution ("CBC") rates applicable to PASNY to be filed with the Commission at least 15 days before the effective date of June 1, 2022. Subsequent annual statements will be filed with the Commission at least 15 days before the Commission's July 16, 2020 Order<sup>1</sup> and August 13, 2021 Order<sup>2</sup>, and in accordance with the PASNY Tariff based on the May 13, 2022 Order<sup>3</sup> all in Case 15-E-0751.

The CBC charges now also apply to Phase One NEM PASNY Customers described in the Phase One NEM - Applicability section of the Net Metering and Value Stack Tariff for PASNY Customer-Generators in the General Provisions of the PASNY Tariff with electric generating equipment that interconnects on or after January 1, 2022, who either remain on Phase One NEM or receive compensation under the Value Stack Tariff will be subject to a CBC Charge for the PASNY Customer's term of service specified in the Term of Service section.

The CBC rates that apply to Phase One NEM customers described in the Phase One NEM Applicability Section of Rider R of the Electric Tariff from CBC Statement No. 2 did not change.

The CBC charge was established to recover the costs from these customers for key policy programs that aid low-income customers and fund energy efficiency and clean energy programs. The CBC rates that apply to Phase One NEM PASNY Customers do not include costs related to the energy efficiency and clean energy programs. The CBC rates will be charged based solely on the nameplate capacity of the applicable generation resource(s) and will not include the nameplate capacity of the energy storage pursuant to the CBC section of Rider R in the Electric Tariff or the Charges and Credits – Customer Benefit Contribution Charge section of the Net Metering and Value Stack Tariff for PASNY Customer-Generators in the PASNY Tariff.

## **Conclusion**

In accordance with the Customer Benefit Contribution Charge section of the Net Metering and Value Stack Tariff for PASNY Customer-Generators in the PASNY Tariff, this Statement is filed with the Commission at least 15 days before the effective date of June 1, 2022.
