RE: Case 20-E-0380 – Proceeding on Motion of the Commission as to the Rates, Charges, Rules and Regulations of Niagara Mohawk Power Corporation d/b/a National Grid for Electric Service

Dear Secretary Phillips:

In accordance with the *Order Adopting Terms of Joint Proposal, Establishing Rate Plans and Reporting Requirements* (issued and effective January 20, 2022) in Cases 20-E-0380 and 20-G-0381 (the "Rate Order"), Niagara Mohawk Power Corporation d/b/a National Grid (the "Company") submits for filing the P.S.C. No. 220 – Electricity tariff leaves listed on Attachment A. Specifically, Ordering Clause No. 5 directed the Company to file, on not less than 30 days' notice, tariff revisions necessary to effectuate the provisions adopted by the Order for Rate Year Two, the twelve-month period ending June 30, 2023, to take effect on a temporary basis on July 1, 2022.

In addition to the Rate Year Two compliance filing, the Company includes language on leaf 372 in the attached filing. During review of the tariff, it was discovered that language on leaf 371 was inadvertently removed in the Company's September 7, 2021 compliance filing in response to the *Order Adopting Net Metering (NEM) Successor Tariff Filings with Modifications* issued August 13, 2021 under Case 15-E-0751. While the omitted language does not currently fit on leaf 371, the addition on leaf 372 corrects that unintentional deletion.

Per Ordering Clause No. 6 of the Rate Order and as required by Public Service Law §66(12)(b), the rates set forth in the revised tariff leaves for Rate Year 2 will be published in newspapers in the Company's service territory. The Company will file proof of publication with the Commission once all publications have been made.

This filing is made in accordance with Appendix 7-H (electronic filing system) to the Commission's Codes, Rules and Regulations (16 NYCRR, Appendix 7-H). As required by the Rate Order, the Active Parties to Case 20-E-0380 have been copied on this filing.
