The purpose of this filing is to reflect rate changes to certain in-state calling plans. Specifically, rates for the following plans will increase by the amounts shown as of the effective date:

- ExpansionPAK II (EPAK II), Voice Advantage and Voice Advantage II In-State Calling Plans (**Rate Group 3**) - \$0.98 rate increase which includes exchanges Canaan, Copake, Hillsdale, Millerton and Pine Plains (The Total Bundle rates will increase by \$2.50 due to either the reallocated business or residential access line rate increase of \$1.52 as shown in the Taconic Telephone Corp. tariff revision effective 05-01-22)
- ExpansionPAK II (EPAK II), Voice Advantage and Voice Advantage II In-State Calling Plans (**Rate Groups 7, 8 & 9**) - \$2.50 rate increase which includes exchanges West Lebanon, Berlin, Chatham, Chatham Center, Stephentown and Nassau (The Total Bundle rates will increase by \$2.50 as shown in the Taconic Telephone Corp. tariff revision effective 05-01-22)
