The purpose of this filing is to increase the rates listed on Attachment A (Table A). A concurrent filing is being made by Taconic TelCom Corp. d/b/a Consolidated Communications Long Distance to reflect the access line increase impact on the bundled rates as well as effect an additional increase to residential and business bundles.

A revenue impact study on these rate increases are included on Attachment A (Tables B and C). The revenue impact is based on February 2022 customer counts.

Taconic Telephone Corporation Intrastate ROE Impact Calculation is included on Attachment B. The calculation is based on the 2020 Annual PSC Report.
