Consolidated Edison Company of New York, Inc. (the “Company”) hereby submits for filing with the Public Service Commission (the “Commission”) amendments to its Schedule for Electricity Service, P.S.C. No. 10 – Electricity (the “Tariff”), applicable to its customers in the City of New York and the County of Westchester. The revised addendum and Tariff Leaves, which are identified below, have an effective date of May 1, 2022.

### **Reason for Filing**

The Commission in its orders issued and effective April 14, 2022, in Cases 19-E-0566, 20-E-0543, 21-E-0536,<sup>1</sup> directed the Company to incorporate into the Tariff the revised Standardized Interconnection Requirements (“SIR”) as shown in the appendices of the April Orders, and to file any necessary tariff amendments.

Pursuant to the April Orders, the Company is filing the Commission’s revised SIR as Tariff Addendum SIR-16. In addition, the Company is filing tariff leaves to update the title of the SIR and for certain costs to be superseded by the SIR.

### **Conclusion and Notice**

These amendments are being filed on not less than five days’ notice to become effective on May 1, 2022. As specified in the ordering clauses of the April Orders, the Commission waived the requirement for newspaper publication.
