Purpose of Filing

The Companies are filing the revised leaves and addenda in compliance with Ordering Clause No. 1 of the Order.

In accordance with the Order, the Companies have revised the tariffs to make the language consistent with revisions to the New York State Standardized Interconnection Requirements and Application Process For New Distributed Generators and/or Energy Storage Systems 5 MW or Less Connected in Parallel with Utility Distribution Systems, Addendum SIR –Standardized Interconnection Requirements (“SIR Addendum”). More specifically, the Companies have revised the tariffs to reflect when the payments have been deemed to have been paid.

The Order also directs the Companies to submit an updated SIR Addendum.

Newspaper Publication

In accordance with Ordering Clause No. 2, the requirements of Section 66(12)(b) of the Public Service Law and 16 NYCRR Section 720-8.1 requiring newspaper publication have been waived.
