## Dear Secretary Phillips:

By letter dated September 16, 2019, Orange and Rockland Utilities, Inc. (the "Company") filed with the Public Service Commission (the "Commission") amendments to its Schedule for Electric Service, P.S.C. No. 3 – ELECTRICITY to become effective February 1, 2020. The filing was made in compliance with the Commission's <u>Order Adopting Terms of Joint Proposal and Establishing Electric and Gas Rate Plans</u>, issued March 14, 2019, in Case No. 18-E-0067 ("Rate Order"). Appendix 17 of the Joint Proposal adopted in the Rate Order required O&R to file, within six months of the Rate Order, a three-part voluntary residential rate that would include fixed, usage, and demand charges.

On December 17, 2019 Commission Staff requested that the Company file a postponement of the effective date of the proposed tariff amendments to June 1, 2020, to allow time for further review of the proposed changes. The Company filed Supplement No. 39 to postpone the effective date of the tariff amendments included in its September 16, 2019 filing. Supplement No. 39 was issued December 19, 2019 with an effective date of January 18, 2020. Commission Staff requested a further postponement of the proposed tariff amendments to allow for more time for review. The Company filed Supplement No. 40 to postpone the effective date of the tariff amendments included in its September 16, 2019 filing to January 1, 2021. Supplement No. 40 was issued April 7, 2020 with an effective date of May 7, 2020. Commission Staff requested a further postponement of the proposed tariff amendments to allow for more time for review. The Company filed Supplement No. 43 to postpone the effective date of the tariff amendments included in its September 16, 2019 filing to July 1, 2021. Supplement No. 43 was issued November 20, 2020 with an effective date of December 20, 2020. Commission Staff

The Company filed Supplement No. 46 to postpone the effective date of the tariff amendments included in its September 16, 2019 filing to January 1, 2022. Supplement No. 46 was issued May 7, 2021 with an effective date of June 6, 2021. Commission Staff requested a further postponement of the proposed tariff amendments to allow for more time for review. The Company filed Supplement No. 48 to postpone the effective date of the tariff amendments included in its September 16, 2019 filing to July 1, 2022. Supplement No. 48 was issued November 17, 2021 with an effective date of December 17, 2021. Commission Staff has requested a further postponement of the proposed tariff amendments to allow for more time for review. The Company accordingly files Supplement No. 51 to postpone the effective date of the tariff amendments included in its September 16, 2019 filing to January 1, 2023. Supplement No. 51 is issued May 2, 2022 with an effective date of June 1, 2022.

The Company requests waiver of newspaper publication of the proposed changes since the Company has already completed publication of the proposed tariff changes and this filing only serves to postpone the effective date of the Company's September 16, 2019 filing.
