Petition of Niagara Mohawk Power Corporation d/b/a National Grid to Modify Pole Attachment Rates

Dear Secretary Phillips:

Niagara Mohawk Power Corporation d/b/a National Grid (the "Company") is filing with the New York State Public Service Commission ("Commission") the following proposed revisions to its Schedule for Electric Service, P.S.C. No. 220 – Electricity (the "Electric Tariff").

Sixth Revised Leaf No. 195
Eighth Revised Leaf No. 196

To P.S.C. No. 220 Electricity
Effective July 1, 2022

Purpose of the Filing:

The proposed revisions to the Electric Tariff are necessary to update the Wireline Pole Attachment Rate in Rule 35.1, and the Wireless Attachment Rates in Rule 35.2. Attachment 1 contains redlined tariff leaves showing where the proposed revisions to the above leaves have occurred.

On November 18, 2019, the Commission issued the "Order Establishing Updated Pole Attachment Rates with Modifications" (the "Order"). in Case 16-M-0330¹. Consistent with the Order, the Company's wireline pole attachment rate is updated to be in parity with the wireless pole attachment rate. Attachment 2 contains the calculation of the proposed wireline and wireless rates. More specifically, the wireless rate calculated on Page 5 of Attachment 2 displays the proposed wireline and wireless rate found in Attachment 1.

Conclusion and Notice:

The Company is filing these proposed revisions to the Electric Tariff to become effective on July 1, 2022. The Company requests a waiver of the newspaper publication requirements of PSL § 66-12 and 16 NYCRR 720.8, as the Company will provide 30 days' notice to the entities that are charged the
