Consolidated Edison Company of New York, Inc. (the "Company") is filing with the Public Service Commission (the "Commission") amendments to its Schedule for Electricity Service, P.S.C. No. 10 - Electricity (the "Electric Tariff"), applicable to its customers in the City of New York and the County of Westchester.

The revised Electric Tariff Leaves, which are identified below, and the Statement of Community Choice Aggregation Data Access Fees No. 2, are filed to become effective on January 17, 2022.

## **Reason for Filing**

The Commission's <u>Order Denying Rehearing</u>, <u>Providing Clarification</u>, and <u>Confirming Tariff Modifications</u>, issued and effective November 18, 2021, in Case 20-M-0082 (the "Order"), directed the Company to modify its current tariffs to remove all established fees associated with the release of customer data, except those cost-based fees associated with requests for historical energy data in excess of 24 months.

## **Summary of Tariff Changes**

Pursuant to the Order, the Company is making the following changes to the Electric Tariff:<sup>1</sup>

- The Company removed the charge associated with the tenant-level data with respect to aggregated company records covering two years or less of data. The charge for data that exceeds two years will remain.
- The Company made the following changes to the Community Choice Aggregation ("CCA") Program:
  - The Company specified that there will be no charges, as reflected on the Statement of CCA Data Access Fees, for aggregated Customer data, Customer-specific data, and account numbers for eligible Customers that did not opt-out of the CCA program.
  - The Company is filing the Statement of CCA Data Access Fees CCA Statement No. 2 to zero out the charges for aggregated customer data and customer-specific data.

## **Conclusion and Notice**

As directed by Ordering Clause 2 of the Order, this filing is being made on not less than one day's notice to become effective on or before January 17, 2022. Pursuant to Ordering Clause 3 of the Order, the Commission has waived the requirement for newspaper publication of these tariff changes.
