RE: Case 20-E-0380 – Proceeding on Motion of the Commission as to the Rates, Charges, Rules and Regulations of Niagara Mohawk Power Corporation d/b/a National Grid for Electric Service

Dear Secretary Phillips:

In accordance with the *Order Adopting Terms of Joint Proposal, Establishing Rate Plans and Reporting Requirements* (issued and effective January 20, 2022) in Cases 20-E-0380 and 20-G-0381 (the “Order”), Niagara Mohawk Power Corporation d/b/a National Grid (the “Company”) submits for filing the tariff leaves listed in Attachment A for P.S.C. 214 – Electric Service for Street, Highway, Roadway, and Other Outdoor Lighting. Specifically, Ordering Clause No. 3 directed the Company to file, on not less than five days’ notice, tariff revisions necessary to effectuate the provisions adopted by the Order for Rate Year One, the twelve-month period ending June 30, 2022, to take effect on a temporary basis on February 1, 2022, and to incorporate any tariff amendments that were previously approved by the State of New York Public Service Commission (“Commission”) since the tariff amendments listed on Attachment No. 2 of the Order were filed.

The requirements of §66(12)(b) of the Public Service Law that newspaper publication be completed before the effective dates of the amendments were waived with respect to the Rate Year One tariff revisions in Ordering Clause No. 6 of the Order. The Company, however, is directed to file with the Commission, within six weeks of the effective date of the amendments, proof that a notice to the public of the changes proposed in the amendments and their effective date has been published once a week for four successive weeks in one or more newspapers having general circulation in the Company’s service territory.

This filing is made in accordance with Appendix 7-H (electronic filing system) to the Commission’s Codes, Rules and Regulations (16 NYCRR, Appendix 7-H). As required by the Order, the Active Parties to Case 20-E-0380 have been copied on this filing.
