## RE: Case 22-E-0064 - Proceeding on Motion of the Commission as to the Rates, Charges, Rules and Regulations of Consolidated Edison Company of New York, Inc. for Electric Service

Dear Secretary Phillips:

Consolidated Edison Company of New York, Inc. (the "Company") is filing with the Public Service Commission (the "Commission") amendments to its Schedule for Electricity Service, P.S.C. No. 10 – Electricity (the "Electric Tariff"), applicable to its customers in the City of New York and the County of Westchester. The Company is also filing amendments to its Schedule for PASNY Delivery Service, P.S.C. No. 12 – Electricity (the "PASNY Tariff"),<sup>1</sup> applicable to delivery by the Company of power and associated energy to Authority Public Customers under the PASNY Tariff.

The revised Electric Tariff and PASNY Tariff leaves, which are identified below, are filed to become effective on April 1, 2024.

(the "Company") dated March 10, 1989, for the Delivery by the Company of Power and Associated Energy to Authority Public Customers."

## **Reason for Filing**

This filing is made pursuant to the Commission's *Order Addressing Cost Recovery of Idlewild Project*, issued January 19, 2024, in Case 22-E-0064 (the "Order"). The Order directed the Company to file tariff revisions to effectuate cost recovery for the Idlewild Project.

## **Tariff Changes**

Pursuant to the Order, the Company added components in the Monthly Adjustment Clause of the Electric Tariff and Other Charges and Adjustments in the PASNY Tariff to recover capital investments placed into plant-in-service related to the Idlewild Project, until such time the costs are included in base rates. Specifically, the Company will recover the return on investment, depreciation expense, and operation and maintenance expense associated with the capital investments. The amount to be recovered under the PASNY Tariff will be based on the PASNY Allocation.

## **Conclusion and Notice**

Pursuant to Ordering Clause 2 of the Order, the Company is filing these changes within 30 days of the issuance of the Order. Pursuant to PSL §66 (12) (b) and 16 NYCRR §720-8.1, the Company will provide public notice of the tariff changes in this filing by means of newspaper publication once a week for four consecutive weeks prior to the effective date of the proposed tariff changes.
