**RE: Cases 14-M-0094 et al., Clean Energy Fund Framework, Case 15-M-0252,  
Utility Energy Efficiency Programs – Statement of System Benefits Charge, and  
Case 18-M-0084, Comprehensive Energy Efficiency Initiative**

Dear Secretary Phillips:

Consolidated Edison Company of New York, Inc. (the “Company”) is filing the annual update to its System Benefits Charge (“SBC”) to its Schedule for Gas Service, P.S.C. No. 9 – Gas (“Gas Tariff”):

SBC – Statement No. 23 to P.S.C. No. 9 - Gas

The Statement is being issued on December 15, 2023 to become effective on January 1, 2024.

This filing is in accordance with General Information Section IX.16 of the Gas Tariff requiring an annual SBC filing in accordance with the following orders of the New York State Public Service Commission: (1) Order Authorizing The Clean Energy Fund Framework, issued and effective January 21, 2016, in Cases 14-M-0094 et al., (2) Order Authorizing Utility-Administered Energy Efficiency Portfolio Budgets and Targets for 2019 - 2020, issued and effective March 15, 2018, in Case 15-M-0252, and (3) Order Authorizing Utility Energy Efficiency and Building Electrification Portfolios through 2025, issued and effective January 16, 2020, in Case 18-M-0084.

EE Tracker Amount to be Recovered

The net Energy Efficiency (“EE”) Tracker amount to be refunded for calendar year 2024 is \$30,075 and reflects the following: (1) \$18,154 to reflect the estimated net under-collection associated with the reconciliation of the EE Tracker funds collected for year 2023, and (2) a

surcharge of \$11,921 to reflect the interest on unexpended EE Tracker funds for 2023 and the reconciliation of interest.

Therefore, the net amount of \$30,075 to be collected through the EE Tracker Surcharge in 2024 is calculated as follows:

Net EE Tracker Under-Collected for 2023	\$18,154
Interest	<u>11,921</u>
Total to be collected through EE Tracker Surcharge	\$30,075

Clean Energy Fund Amount to be Recovered

The net Clean Energy Fund amount to be collected for calendar year 2024 is \$4,777 and reflects the following: (1) the Gas Clean Energy Fund collection target of \$0 for 2024 and (2) \$4,777 to reflect the estimated net under-collection associated with the reconciliation of the Clean Energy funds collected for year 2023.

Therefore, the net amount of \$4,777 to be collected through the Clean Energy Fund Surcharge in 2024 is calculated as follows:

2024 Clean Energy Fund Collection Target	\$ 0
Net Clean Energy Fund Under-Collected for 2023	<u>4,777</u>
Total to be collected through Clean Energy Fund Surcharge	\$4,777

As shown on the revised SBC Statement, the EE Tracker Surcharge is 0.0018 cents per therm and the Clean Energy Fund Surcharge is 0.0003 cents per therm. As required by General Information Section IX.16 of the Gas Tariff, the Company is filing its SBC Statement no less than fifteen days before its effective date.
