## RE: Case 15-E-0751, In the Matter of the Value of Distributed Energy Resources

Dear Secretary Phillips:

Consolidated Edison Company of New York, Inc. (the "Company") is filing the Statement of Customer Benefit Contribution ("CBC Statement") to the Schedule for Electricity Service, P.S.C. No. 10 – Electricity (the "Electric Tariff").

CBC – Statement No. 5 to P.S.C. No. 10 – Electricity

The CBC Statement is being issued on December 15, 2023 to become effective on January 1, 2024.

## Reason for Filing

This filing is made pursuant to Rider R – Net Metering and Value Stack Tariff for Customer-Generators of the Electric Tariff and the Net Metering and Value Stack Tariff for PASNY Customer-Generators in the General Provisions of the Schedule for PASNY Delivery Service for Consolidated Edison Company of New York, Inc. ("PASNY Tariff"), which require an annual filing to set the Customer Benefit Contribution ("CBC") Charges for each calendar year in accordance with the Commission's July 16, 2020 Order, August 13, 2021 Order, and in accordance with the PASNY Tariff based on the May 13, 2022 Order in Case 15-E-0751.

The CBC charges apply to Mass Market Phase One NEM customers described in the Mass Market Phase One NEM Applicability Section of Rider R of the Electric Tariff with electric generating equipment that interconnects on or after January 1, 2022, who either remain on Mass Market Phase One NEM or receive compensation under the Value Stack Tariff for the customer's

term of service as specified in Rider R. The CBC charges also apply to Mass Market Phase One NEM PASNY Customers described in the Phase One NEM - Applicability section of the Net Metering and Value Stack Tariff for PASNY Customer-Generators in the General Provisions of the PASNY Tariff with electric generating equipment that interconnects on or after January 1, 2022, who either remain on Mass Market Phase One NEM or receive compensation under the Value Stack Tariff. Customers will be subject to a CBC Charge for the PASNY Customer's term of service specified in the Term of Service section.

## Conclusion

In accordance with Charges and Credits – Customer Benefit Contribution Charge Section of Rider R, this Statement is filed with the Commission at least 15 days before the effective date of January 1, 2024. The Company also includes with this filing the workpapers showing the development of the rates contained on the CBC Statement.
