The enclosed Supplement No. 8 to P.S.C. No. 2 – Electricity, effective December 14, 2023, is hereby transmitted electronically for filing in compliance with the requirements of the New York State Public Service Commission. Fishers Island Electric Corporation ("FIEC") proposes to postpone the effective date of the tariff amendments filed July 17, 2023 in the above-referenced proceeding from December 1, 2023, to April 1, 2024, to accommodate a new notice and comment period pursuant to the State Administrative Procedure Act ("SAPA") for the revisions to Tariff leaves 86 and 87 that FIEC is concurrently filing in this proceeding. However, should Department of Public Service Staff ("Staff") determine that a new notice and comment period is not required under SAPA, FIEC respectfully requests approval of the revisions as soon as practicable. FIEC requests that Supplement No. 8 become effective November 30, 2023 on short notice—less than30 days after this filing—so that FIEC's original Tariff revisions are postponed before their December 1, 2023, effective date.
