Dear Secretary Phillips:

The enclosed tariff leaves, issued by New York State Electric & Gas Corporation ("NYSEG") and Rochester Gas and Electric Corporation ("RG&E") (together the "Companies"), are being transmitted for filing in further compliance with Ordering Clause No. 3 of the New York State Public Service Commission's <u>Order Adopting Joint Proposal</u> (the "Order"), issued and effective October 12, 2023 in the above-referenced proceedings. This filing is also made in accordance with Appendix 7-H (electronic tariff filing system) of the New York State Public Service Commission's ("PSC" or "Commission") Codes, Rules and Regulations (16 NYCRR Appendix 7-H). Appendix A sets forth a list of the revised tariff leaves pertaining to the following Schedules:

Purpose

The purpose of this filing is to provide housekeeping revisions and minor corrections to the Companies' initial compliance filing submitted on October 27, 2023 in the above-referenced proceedings. The Companies have updated Section letters within the General

Information Rule sections to correct inconsistencies. In addition, references to rule numbers that were "Reserved for Future Use" have been removed from affected tariff leaves and updated to refer to the correct rule. The Companies have also updated Bill Processing charges applicable to ESCOs to be consistent with the Bill Issuance Charge. There is a revision included to Leaf No. 193.1.1 of RG&E's tariff schedule P.S.C. No. 19 to reflect the rates that were approved in the Joint Proposal that were inadvertently omitted from the Companies initial compliance filing. There is also a housekeeping change included for Leaf No. 109.1 of NYSEG's tariff schedule P.S.C. No. 120 to consolidate revisions that were approved in Case 14-M-0224 to the Community Choice Aggregation Program and revisions that were approved as part of the Joint Proposal that were approved in the Order. A list of the leaves being filed and the change being made are listed in Appendix A. These tariff revisions will become effective on November 19, 2023 on a temporary basis.

Newspaper Publication

The Companies request waiver of publication of these proposed changes in accordance with Section 66(12)(b) of the Public Service Law and 16 NYCRR Section 720-8.1, as these revisions have been previously approved by the Commission or are housekeeping in nature.
