Re: Case 01-G-1092 - Tariff filing by Consolidated Edison Company of New York, Inc. to make revisions as they relate to service to its interruptible and off-peak firm customers

Dear Secretary Deixler:

Consolidated Edison Company of New York, Inc. ("Con Edison" or "the Company") submitted on August 6, 2001, changes to its Schedule for Gas Service, PSC No.9 – Gas, related to service to its interruptible and off-peak firm customers taking service under Service Classification ("SC") Nos. 9 and 12. Certain of the changes were made in compliance with the Commission's January 31, 2001 Order Adopting Permanent Rule ("January 31st Order"), and additional changes were made to the charges applicable to interruptible and off-peak firm customers that repeatedly violate the terms of the tariff. The changes were to become effective on November 1, 2001. On October 18, 2001, the Company filed Supplement No. 13 postponing the effective date of the tariff changes to December 1, 2001.

On November 28, 2001, the Commission issued an order ("November 28th Order") which approved the Company's proposed changes, provided that certain modification be made as

follows:

E Tariff provisions that permitted the Company to transfer customers to firm service if they violate the Company's tariff and operating procedures on two or more occasions have been deleted. However, the current tariff still allows the Company to discontinue interruptible or off-peak firm service to a customer where there is a violation of tariff provisions. In addition, the provision that precludes any interruptible or off-peak firm customer who has switched to firm service from returning to interruptible or off-peak firm service for a minimum of one year, has remained.

E Tariff provisions that permitted the Company to make the effective date of changes to the Sales and Transportation Operating Procedures on the first day of the second calendar month following their submission to Staff have been deleted. Such changes will be permitted either thirty days after providing notice of the changes or sooner with approval of Staff.

In compliance with the Commission's November 28th Order, the tariff leaves submitted herewith in Attachment A reflect the above modifications and are issued November 30, 2001 with an effective date of December 1, 2001. The November 28th Order has also directed that the requirements for newspaper publication be waived.

Revisions to the Company's Sales and Transportation Operating Procedures will be submited under separate cover to Commission Staff and all Marketers and Direct Customers. These revisions will reflect both the modifications described above and revisions whereby the Company will clarify its current notification practices relating to monthly and intra-month changes.
